2016 Projects – Recap & Celebrate!

Krzepice – Kevin

- Polish speaker needed for this trip. Joe Vaughn's partnership was critical to the success of this project this year
- Goal: Maintenance self-sustaining by community
- Possible that work could have been completed w/ better cooperation from city
- Will require one more year to complete first pass through cemetery
- Kevin's Take-away: Less self-focused

Nasielsk – Steven

- Three working days in the cemetery
- Worked with Przemek, who is willing to partner and is now in a position to lead a project
- Steven emphasize a quote from Glen, "You are great people doing great work"
- Steven's Take-away: Meeting formally with the city prior to the project is critical

Markuszow – Rachel

- First time working with Jewish volunteers & descendants
- "We became part of their story"
- Entire cemetery cleared
- Memorial marker did not include recognition of TMF contribution
- Rachel's Take away: Priority to work with descendants
- Elaine's Take-away: Watching the transformation of the family was priceless
- Cindy's Take-away: Loved the interaction between Christian & Jew, didn't feel a divide

IHRA Project – Steven

- Surveyed 10 cemeteries near Oswiecim
- Work compelled Steven to redefine his own role and perception in this work on a larger scale

Oswiecim – Jo

- First project with an outside volunteer – everything went well on that front
- We partnered with seven different entities during this project. That highlights a bit

- of the complexity involved with what we do
- Spoke about Piotr, his desires for next year & future years, and how we've already seen results from that

Hillary's summaries: We reviewed the summaries as we went through each project. Everyone agreed that they're a good thing and a great start!

Where do we go from here? At some point we should gather volunteer feedback.

Best Practices developed by Steven & Marla:

- 1) Common goals established prior to project
- 2) Worked collaboratively (and respectfully)
- 3) Local Liaison vital
- 4) TMF provided equipment, technical and financial mgmt. of project
- 5) Meeting with mayor (city officials) prior to project inception
- 6) Administrative support in securing permissions and installation of memorial (provided by Foundation of Forgotten, FODZ, etc)
- 7) Descendant involvement
- 8) Combined team met with local leadership prior to ceremony
- 9) Personal visits w/ neighbors raised awareness & attendance at ceremony
- 10) Communal housing & meals key element in building a sense of community and cooperation
- 11) Daily (evening & morning) debrief discussions facilitated dialogue
- 12) Collaborative pre-planning assisted in the execution or implementation of the project
